

## Standard Settlement Instructions (SSI's)

## Barclays Europe – Portugal branch

To assist in routing currency payments to accounts held with Barclays Europe Portugal branch, we have listed below the relevant currency correspondents. Payments may either be sent via the Direct and Cover method (if the remitting institution has exchanged an RMA with BARCPTPCXXX), or the Serial method:

Direct and Cover routing: Please pay direct via MT103 to Barclays Europe Portugal branch at BARCPTPCXXX, with separate cover message (MT202COV) to the below correspondent for the currency being remitted. (Ex: BARCDEFFXXX for the payments in EUR, BARCGB22XXX for the payments in AED)

Serial routing: Please pay indirectly via MT103 to the below correspondent for the currency being remitted, for onward payment to Barclays Europe Portugal branch at BARCPTPCXXX.
